### **COVID-19 STATEMENT OF RISK - PLEASE READ CAREFULLY**

Dear participant, we are thrilled you will be participating in a DiscoveryBound program. In our efforts to abide by state and federal regulations and help limit potential exposure of both our guests and staff to the COVID-19 virus, we ask you to abide by the following:

1. If you have COVID-19 or any symptoms of COVID-19 (cough, sore throat, loss of taste/smell, fever, aches, chills or shortness of breath) or otherwise do not feel well, do not come to the program;
2. If you have recently been exposed to someone who has or whom you suspect may have COVID-19, do not come to the program;
3. While at the DiscoveryBound program, you may be required to maintain social distance (including no high fives, hugging or shaking hands) and to wear a mask at designated times or when asked to do so;
4. Participants will be expected to wash their hands or use hand sanitizer when entering and exiting the dining areas, and when otherwise asked;
5. Since DiscoveryBound will be taking enhanced measures to keep facilities clean, camp participants will be expected to cooperate in keeping facilities tidy to promote cleanliness;
6. If a participant or staff is exhibiting multiple COVID-19 symptoms they will be placed in isolated care, or if a participant or staff is exposed to another with COVID-19 symptoms they will be asked to temporary quarantine;

7. Participants will need to have the ability to leave the program or arrange transportation for them to leave the trip within 48 hours, if deemed necessary by DiscoveryBound management;
8. You understand that programming and some normal activities may be different and impacted by the current pandemic.

As you will see DiscoveryBound, consistent with guidance from the Center for Disease Control (CDC) and the American Camping Association (ACA), we have taken a series of steps to help reduce the risk of exposure to the COVID-19 virus while you are here. This includes but is not limited to altering our operations to help keep down the number of participants at the event at any one time to facilitate increased and enhanced cleaning procedures. While the CDC and other experts agree that these steps are effective in reducing the risk of potential exposure, they are not foolproof. As such,

By participating in a DiscoveryBound program you, on behalf of yourself, agree and acknowledge that you are aware of and understand that participating in a program with DiscoveryBound and the surrounding area may entail known, unknown, inherent and unanticipated risks including but not limited to potential exposure to viruses such as COVID-19, that cannot be eliminated without jeopardizing the essential qualities of the activities offered by DiscoveryBound. You further agree and acknowledge that coming to the DiscoveryBound trip is voluntary, deliberate, of your own free will and with the full knowledge of the inherent risks, hazards and dangers involved. By coming you knowingly and willingly accept and fully assume the risk that you or those accompanying you may get hurt, be exposed to natural pathogens, bacteria or viruses, suffer personal injury or loss or worse, whether caused by the ordinary negligence of Adventure Unlimited or any of its managers, members, employees, volunteers, agents, or affiliates or resulting from any other cause. Finally, by coming you knowingly and intentionally agree to indemnify and hold harmless Adventure Unlimited and its employees, volunteers, managers, officers, directors and shareholders, from and against any and all claims, actions, causes of action, liabilities, demands, losses, damages (known or unknown and economic or non-economic), suits, and expenses (including reasonable attorneys' fees) arising out of your access to or participation in DiscoveryBound programs.
